Important events that need to be reported: Key Financial Indicator 2024 – Preliminary Consolidated Turnover (Unaudited)

DN AGRAR GROUP S.A. ([DN](#)) informs the shareholders regarding the preliminary (unaudited) consolidated turnover achieved in 2024.

For 2024, the preliminary consolidated financial turnover registered was 175 million RON, an increase of 16% compared to 2023. The result was supported by an increase in the selling milk price of 2.76%, and also by an increase with 14% in the quantity of milk delivered versus 2023.

Compared to the published budget for 2024, DN AGRAR's preliminary turnover (unaudited), at consolidated level, was 14% higher than estimated.

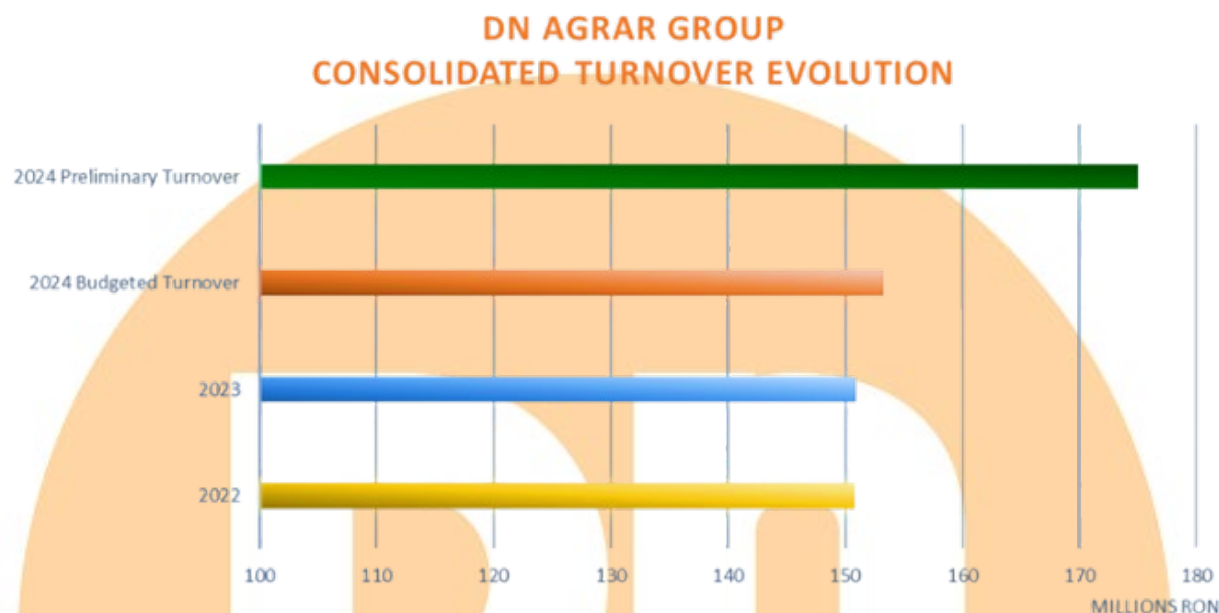

Regarding the milk delivered in 2024, DN AGRAR has achieved a significant milestone by successfully exceeding its target of 60 million liters for 2024, delivering approximately 63 million liters of milk.
